

OFFICIAL RULES
NORTHWEST GROCERS “SUMMER GRILLING & ENTERTAINING” SWEEPSTAKES
08/03/2022 to 08/30/2022

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR CLAIM PRIZE. A PURCHASE WILL NOT IMPROVE YOUR ODDS OF WINNING.

You will receive a reply text message with a link to the Sweepstakes entry website (the “Website”). Keyword “*SUMGRILL22*” must be spelled correctly to generate an autodialed reply text message. Click on the link in the message to access the mobile website and follow the instructions to complete and submit the entry form (“Mobile Entry”). Standard messaging and data rates apply when submitting a Mobile Entry and for all text messages sent and received. Participation via text message may not be available from all service providers or for all handsets. Consent to receive text messages is not a requirement or condition of any purchase. Check with your service provider for details. To quit, text STOP to 65047. Limit one (1) entry per person, email address, phone number and IP address.
